1. Your personal data administrator.

3. The purposes of and the legal basis for the personal data processing.

We will process your personal data in connection with the organisation and participation of in the conference entitled "Od mobilności do interakcji. / From mobility to interaction" which will take place on 07.11-09.11.2018 in Sosnowiec and Katowice, for purposes related to:

- 1. contact in organisational matters
- 2. drawing up lists of participants (identifiers)
- 3. preparing and sending a post-conference publication.

The legal basis for processing your personal data is based on Article 6, par. 1 (a) and (f) of the General Data Protection Regulation (EU) 2016/679 of the European Parliament and of the European Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and the free movement of such data and on the repealing of Directive 95/46/EC (general regulation Data Protection Regulation).

- 1. Your consent to the processing of your personal data provided in the application form is for the purpose of organizing and participating in the conference. *Providing personal data is voluntary, however the refusal to provide it makes it impossible to register for the conference. Providing contact details, i.e. telephone number, e-mail address is not necessary, but it will enable contact with you.*
- 2. Legitimate interest pursued by the data administrator, that is dissemination of the images of conference participants in the form of group photos is for information purposes only.

4. The storage period of your personal data.

We will store your personal data even after the conference, until the article is submitted for print.

5. The recipients of the data.

Your personal data will be passed on to the hotel, the services of which will be used by conference participants and to the entities authorized to obtain data on the basis of applicable laws.

6. The rights related to the processing of personal data.

You have the following rights in relation to the processing of personal data:

- 1. the right to withdraw consent to the processing of data, with the exception of the data contained in durable media (printed in conference materials);
- 2. the right of access to your personal data;
- 3. the right to request that your personal data which is incorrect be corrected and that incomplete personal data be supplemented;
- 4. the right to demand the deletion of your personal data, in particular in the event of your withdrawal of your consent to the processing, if there is no other legal basis for the processing;
- 5. the right to demand that the processing of your personal data be restricted;
- 6. the right to object to the processing of your personal data on the basis of your specific situation, in the cases where your data is processed on the basis of our legitimate interest, including for the purposes of direct marketing, or for the performance of a public task. NOTE: in the case of processing for direct marketing purposes, you may object to the processing at any time, regardless of the specific situation;
- 7. the right to transfer your personal data, i.e. the right to receive your personal data from us, in a structured, commonly used machine-readable electronic format. You may send your data to another controller or request that we send the data to another controller. However, we will only do this if this is technically possible. You have the right to transfer your personal data only with regard to the data that we process automatically, i.e. in electronic form, on the basis of a contract with you or on the basis of your consent;
- 8. the right not to be subject to automated decision-making only, including profiling;
- 9. the right to lodge a complaint to the supervisory authority responsible for personal data protection, i.e. the President of the Office for Personal Data Protection.

Right of withdrawal of consent

To the extent that your data are processed on the basis of your consent, you have the right to withdraw your consent to the processing of your data at any time. Withdrawal of consent does not affect the lawfulness of the processing that was carried out on the basis of your consent prior to the withdrawal of consent.
